Areas of Growth Orchard School

- Orchard ELA total 18.16% of students assessed exceeded grade level standard.
- Orchard Math scores increased significantly for students in middle school. 20% of 7th graders exceeded the grade level standard (in 2022, as 6th graders, none exceeded the grade level standard).
- From 2022 to 2023 from 4th grade to 5th grade students in ELA met and or exceeded standards the % increase went from 24% to 61%.

Areas of Growth River School

- In 2023 70% of River's 5th grade students met or exceeded the standard for ELA, as compared to 2022 in 4th grade only 27% met or exceeded the standard.
- In 2023 28% of River's 7th grade students met or exceeded Math standards, as compared to 2022 in 6th grade only 10% met or exceeded the standard in Math.

Orchard enjoyed its 2nd annual Grandparent's Day today with performances by 3rd, 4th, and 8th grades, bringing tears of joy to many hearts. The children enjoyed sharing their special day with Grandparents and family friends. Overall, teachers were pleased at how well their students behaved for their special guests and could feel all the extra love spread throughout the school. The third-grade Baobab students invited their guests into the Sukkah they built for Sukkot and shared a blessing together as a part of the Hebrew Legends curriculum. The fourth grade Bluebells welcomed many of the same grandparents from May, who commented on the growth in the students in such a short time. Faculty feedback was overwhelmingly positive for the day. Teachers preferred the switch to October over May, since it is a slower time of the school year. The one change teachers expressed was allowing more grandparents to come as some children felt left out, and possibly limiting it to one grandparent/family friend per student. Teachers preferred guests staying for the whole time rather than switching between classes.

Courage Day recap: Orchard enjoyed Sir George and the Dragon performed by the 2nd and 6th grade with a slight plot twist this year. Instead of the King drawing straws, a Queen drew the shortest straw. The class was beaming with enthusiasm and chanted their lines loud and clear for all to hear. The children enjoyed themselves all afternoon with activities on the field. Highlights included an extra loud snoring sleeping dragon, javelin throwing, pillow jousting, face painting, slack line, tug o' war, and story time.

October is book month, and classes will be working on creating book jackets, writing to authors, and getting excited about reading. This year for Halloween, children will be allowed to dress as their favorite book character in addition to characters from the curriculum, as long as costumes are media free and dress code appropriate.

Board of Trustees Report: October 11, 2023

"The autumn winds blow open the gate, oh Michael for you we wait." This is the opening line of one of my favorite autumn verses, one that is recited every day in my second-grade circle. In its entirety, it speaks to many things such as courage and bravery in facing our metaphorical dragons, but it also welcomes in the new season, as well as each other with a good morning greeting and handshake celebrating unity and community.

Last Friday was a very special day at Golden Valley; our Day of Courage. It is a celebration based on the European festival of Michaelmas, where our second grade Manzanita class treated the school to a wonderful performance of Sir George and the Dragon. In the play, it is though the courage of both Sir George and the princess, working together, that the terrible dragon is defeated; who is not evil but just a bit misguided. And through their compassion and empathy, the defeated dragon is spared and given a new life within the community.

There is a lot of symbolism in this play, but the idea of "restorative justice" is one that stands out to me. This is something we practice here at Golden Valley, where talking through issues, looking at different perspectives, walking in the shoes of others, owning mistakes and apologizing for our missteps, is practiced throughout the grades. We focus on being able to forgive and restore others when they do stumble, because this is something we all do, often, in fact. It's not a crime and punishment model, but one that is heart based, thoughtful, and impactful. I saw this first hand when I sat down with Mrs. Moraga, one of her students, and one of mine concerning an incident that happened. The 5th grade student was able to voice how they felt and how it affected them and the seventh gadder was given the opportunity to listen, in a non-threatening manner, and thus, wasn't on the defensive. They heard the other and were able to apologize, allowing the other to be made whole again. Both students were restored and lifted back to where they needed to be. I love this about our school! I know I'm getting off track here, but I thought about this moment as I watched George restore the dragon instead of slaying it.

So again, back to Courage Day which was a smashing success! I saw many curly mustaches on the faces of my students, as the talented 8th grade face painters were in full effect. New games, such as the three-legged rely race, were a big hit (according to my daughter, "It was my favorite activity"). And the Sleeping Giant was as popular as ever! I don't know how he does it but, again, the giant was able to successfully sleep through the entirety of the event. Kudos to Ms. Parker and Mrs. Strawn for their excellence.

Last time out I mentioned how wonderful our two new music teachers are, and that statement is still true. However, Mr. Matt Brown is now our new upper grades Music teacher partnering with the very talented Mrs. Kilpatric in the lower grades. Mr. Brown reports, "My first week went okay... or dare I say good." Knowing Mr. Brown quite well, there is no doubt he has the patience and personality to lead the upper grades. And Mrs. Kilpatrick's class are the closest I have seen to the great Andra Pranto's classes of the past. Music is in good hands at Golden Valley.

Mrs. Bosque is feeling positive about how our kindergarten program is adjusting to the new challenges of having TK aged children. She was able to meet with all the kinder teachers across both schools and create a list of needs to address these new challenges. Moreover, they have a meeting set in December to bring their ideas to leadership. Also, Mrs. Bosque wanted to share that this new group of kinder parents have been amazing. In fact, she had 100% attendance at her last parent meeting. "They are eager to learn and seem to have a great desire to create community" which is such a positive thing to hear. These kindergarten parents are our future grades parents, and the stronger the foundation created by the teachers and parents in kindergarten, the stronger, more community-based classes we will have moving through the grades.

So, all of this is very positive news, and it's all true. And there are so many other examples that occur daily at Golden Valley. But we also have our challenges and struggles. If I am remembering my Waldorf training correctly, Steiner understood the young child lives in the physical world as they develop their physical body. They learn through imitation and need the etheric body, or life forces/attention and energy, of the adults around them (teachers and parents) while they come into their physical body and then develop their own etheric. Hence, the exhaustion kindergarten, first, and even second grade teachers feel at the end of the day. But I feel, more and more, this has become prevalent across the grades, where teachers and staff members are giving so much of their own etheric due to the social and emotional needs of the children. Teaching is a wonderful profession, a giving profession, and a rewarding profession, but in this day and age, it's taking its toll. I realize I just turned 50, but I have never felt so exhausted at the end of the day than I do now; "now" being the years following the pandemic. It's not to complain, as we have all chosen this path, but please know teachers are pretty overwhelmed and feeling the weight of a new reality. Please continue to support Mrs. Miller and the Renewal Room which/who is so vital. And please consider funding any future support systems, extra help, or whatever may be needed to address the needs of the modern school and student.

THE CHARTER MANAGEMENT OFFICE

The Board meeting will be followed by a Town Hall meeting to discuss some of our long range goals around facilities and enrollment growth. The finance committee met around the status of our current budget and we are recommending a one-time bonus of 1% to returning employees. Our Grandparents Day at Orchard was a huge success with over 70 participants in grades 1-8. Next week we will have a slightly different format at River but also including classroom visits and student performances. We invited Grandparents to volunteer, support our upcoming Eagle Chase fundraiser, and to attend our many festivals.

In October, River will be received brand new handmade wood desks for the class. Orchard will be installing a new shed for the afterschool program. I met with the head of maintenance around some safety items at Orchard. I also met with the director of enrollment for San Juan who is going to offer a talk for our parents around the transition to high school. For the first time since the pandemic began, all of the in-district charter schools will again be collaborating in person. Our big national event this year in the Alliance for Public Waldorf Education conference at the River School in January.



Orchard School – This past month at Orchard we recognized the Madrona 2nd grade, Catalpa 1st grade, and Sequoia 6th grade class for their excellent attendance. We will now move to monthly attendance recognition as we acknowledge and thank all who are making attendance a priority. To support student learning and social/emotional development, it's important to stay home if you're ill and be present if you are well. Scheduling vacations during our breaks and appointments in the afternoon or during a break is helpful for your student's education. Grandparents' day was a joyful event at Orchard. Teachers and students loved having grandparents join the classrooms. So much so that part of our faculty discussion around the day was how we can accommodate more grandparents or family friends joining for the day. Our Courage Day started off with the 2nd g grade Madrona class performing a splendid rendition of "Sir George and the Dragon". We ended the day as we kicked off our food drive with nonperishable items that were donated to the Orangevale Food Bank, supporting local families in need. Students ended the day with activities such as tug-o-war, archery, the Sleeping Giant, and pillow jousting. Students continue to SOAR at Orchard as they demonstrate being Safe, Outstanding, Accountable, and Respectful. After earning SOAR tickets for these virtues, they can turn them in on Friday at the SOAR store for stickers, spirit sticks, friendship bracelets and more.



River School - October is shaping up to be a very busy month at River campus. Eagle Chase is the major focal points for our school this month. This past Friday we kicked off our Eagle Chase campaign with a presentation at our Friday gathering. Last year we managed to raise more money than ever before with over \$60,000. This year, our goal is to raise \$75,000, and we are confident

in the enthusiasm of our students and families to do just that. But at Golden Valley, our focus is not just on the school community, but on the greater community as well. Last Friday at our Day Of Courage celebration, we were able to collect over 300 pounds of food for the Orangevale Food Bank while exercising one of our core values- joyful service. Later this month we look forward to our first big festival of the year at the River campus, the Festival of Light, where we will be celebrating various seasonal and cultural traditions from around the world, such as Diwali and Dia de los Muertos. There will be food, live music, storytelling, crafts, and so much more! Lastly, our virtue for the month of October is Assertiveness. Assertiveness is a virtue that requires an incredible amount of courage to exercise. Speaking your truth, setting healthy boundaries, and standing up for what is right is never easy, but always necessary. By modeling proper assertiveness for our children, we impart confidence and teach them to advocate for themselves in constructive ways.

ACCOUNTABILITY & COMPLIANCE

The local indicators, which were reported to the board in June 2023, were submitted to the state last week. The data reported is used to populate part of the CA School Dashboard which will be released in December 2023.

Title I students have been chosen based on achievement data for the 2023-24 school year as part of the Title I Targeted Assistance School process. Parents of selected students will soon be invited to attend an informational meeting at their schools to learn about how students were selected, plans on spending Title funds this year to help support the academic achievement of selected Title I students.

ENROLLMENT

Enrollment – We have recorded Parent Information Meetings available for prospective families to watch as well as scheduled in person meetings. We will continue to accept applications and make offers for enrollment when there is an open seat in a class.

Outreach – In October we will have an outreach booth at the annual Nature Fest hosted by Effie Yeaw Nature Center. Our purpose is to promote our two schools offering an activity and information about our curriculum.

Applications for Enrollment for the 2023-24 school year will continue to be accepted. Additional Parent Information Meetings (PIM) are scheduled for October for families to learn more about GVCS and learn how to apply.
