Agenda Proposal: Open Enrollment & Tiered Benefit Contribution Plan

Date: 09/10/2025

Background:

Golden Valley Charter School is preparing for the 2025–2026 Open Enrollment period. Recent medical rate increases from our carriers are significant:

- **Kaiser:** +7%
- **Sutter:** +14%
- **WHA:** +20%
- **PPO:** +17%

These increases will impact employees adding dependents or enrolling in family coverage. Currently, all employees receive the same employer contribution regardless of coverage tier.

- If no changes are made, the highest out-of-pocket cost to an employee next year could be \$1,135.39 per pay period or \$2,270.784 per month.

Proposed Tiered Employer Contribution (per pay period):

- Tier 1 (Employee Only): \$550
- Tier 2 (Employee + Dependent): \$600
- Tier 3 (Family): \$650

Rationale:

- The additional \$50 per pay period contribution for dependents equates to approximately 25% of the cost of insuring one child.
- The additional \$100 per pay period contribution for family coverage equates to approximately 25% of the cost of insuring two children.
- This approach aligns with common employer practices and creates a more balanced structure without overextending school resources.

Comparative Employer Contributions:

- **Camino Nuevo Charter Academy (Southern CA):**

- \$350/mo – Employee
- \$475/mo – Employee + One
- \$600/mo – Employee + Family
- (plus 50% of remaining out-of-pocket)

- **Choices Charter School (San Juan District):**

- Kaiser Employee Only: \$1,121.76 (100% covered)
- Employee + One: \$2,243.52 (\$280.44 employee cost)
- Family: \$3,174.58 (\$513.20 employee cost)

These examples illustrate that tiered contributions are standard practice across charter and district schools and government agencies.

Recommendation:

Adopt the Proposed Tiered Benefit Plan beginning with the 2025–2026 Open Enrollment period:

- Approve employer contributions at \$550 (Employee Only), \$600 (Employee + Dependent), and \$650 (Family) per pay period.
- Ensure alignment with comparable schools while maintaining fiscal responsibility for Golden Valley Charter School.

Action Item: Specialty Teacher and Specialist Positions and Salary Schedules

Presenter: Eileen Worthing, Human Resources Manager

I am requesting that the Board of Trustees approve updating the Specialty Teacher job positions by creating two distinct roles, Specialty Teacher (Exempt) and Specialist (Non-Exempt), in order to accurately reflect credentialing requirements under California law and ensure proper alignment with FLSA exempt and non-exempt classifications.

Currently, Specialty Teacher positions (such as Fine Arts, Handwork, Cultural Studies, Music, etc.) have been used for both credentialed and non-credentialed staff, which has been an incorrect practice. To address this, I recommend splitting these into two distinct roles:

- **Specialty Teacher (Exempt):** Must hold a valid California teaching credential and is legally able to serve as teacher of record in a public school setting. Teachers in these roles are exempt employees. They will be placed on the certificated salary schedule.
- **Specialist (Non-Exempt):** Does not require a teaching credential; education can be substituted with work experience. These roles are hourly, classified, and placed on the non-exempt salary schedule. By law, a non-exempt employee without a credential cannot serve as the teacher of record in California. Therefore, a credentialed teacher must remain in the classroom, maintain instructional oversight, and be responsible for grades.

The distinction between exempt and non-exempt status is important:

- **Exempt employees** are salaried and perform instructional duties requiring certification.
- **Non-exempt employees** are hourly, subject to overtime laws, and cannot independently fulfill the legal requirements of a credentialed teacher.

We deeply value the contributions of our current Specialty personnel. To recognize their work fairly while correcting these classifications, I propose placing the Specialist positions on **Range 10** of the Classified Non-Exempt Salary Schedule, with hourly rates beginning at **Step 1: \$27.00** and progressing to **Step 12: \$37.37**, as outlined below:
